## REACH AND ROHS COMPLIANCE DECLARATION

We hereby certify that our articles are fully comply with the related requirements of European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) :

1. Under the structure of the REACH regulation, our Company is a manufacturer of “**ARTICLES**” to our EU customers. We do not manufacture “substances” or “preparations” and our articles do not involve the intentional release of substances. There is no registration or preregistration or authorization requirement for the product that we supply.
2. With regard to the requirements of article 33 of REACH: Duty to communicate information on substances in articles. We declare that none of the SVHC (Candidate List of substances of very high concern for Authorisation published in accordance with Article 59 of the REACH Regulation) is present in our article in a concentration equal or above 0,1%
3. With regard to the requirement of article 67 of REACH: A substance on its own, in a preparation or an article, for wich Annex XVII, contain a restriction shall not be placed on European market or used unless it complies with the condicions of that restriction. We declare that none of the substances in the condiction of restriction is present in our product.

As REACH regulation is updated frequently, for the major changes afterwards, such as the addiction of SVHC substances into Annex XIV, the addiction of restricted substances in Annex XVII, our Company will evaluate further revise in time and update the declaration to reflect these changes.

If no new Declaration is submitted, the validity of what is stated in this document is considered to be in conformity.
