REACH REGULATIONS

Regulations EC n.1907/2006 concerning the registration, evaluation, authorization and restriction of chemical substances.

Dear Customer,

REACH Regulations establish procedures concerning chemical substances which apply to production, import, market launch and using these substances as such or as components for chemical preparations or for items.

Notably, section 33 of the REACH Regulations obliges to communicate at the end of the production line, the presence of substances of very high concern (SVHC) which comply with the criteria stated in section 57 (classified as substances that cause cancer or gene mutations or that are toxic for reproduction) when they are present in concentrations above 0.1% (weight/weight), and included in the substances of very high concern list in line for authorization (issued in compliance with section 59, paragraph 10 of the REACH Regulations https://echa.europa.eu/it/candidate-list-table the last available update being that of 14/06/2023.

The European Waste Directive table 2008/98/CE, modified by Directive EU 2018/581, delegated to the European Agency for chemical substances (ECHA) the creation of the SCIP database for "substances of concern in items, as such or in complex objects (products)". Item suppliers and importers must provide information in compliance with section 33, paragraph 1, of REACH Regulations (EC) n. 1907/2006 to their direct business recipients and to the European Agency for chemical substances (ECHA), by means of an SCIP notification of the item containing SVHC in concentrations above 0.1% (weight/weight). This notification is to be sent to the customers as well.

In case a purchased chemical product contains one or more substances present in the Candidate List or in annex XVII of the REACH Regulations, the supplier shall communicate it by means of a safety compliance sheet.

Arvedi Tubi Acciaio

- States that it complies with the regulations and is up to date on the recent provisions on the updates to annexes XIV and XVII as well as that it monitors any substance present in the Candidate List which may be potentially present in our production line.
 - No SVHC substance which has been classified so far in the aforementioned list is used or present in concentrations above 0.1% (weight/weight) in its items.
- It is committed to monitoring the list of substances of very high concern (Candidate List) and to send a notice if any of these substances is present in an item in concentrations above 0.1% (weight/weight) and to provide suitable information for using the item (Section 33 of the REACH regulations).
- It is committed to monitoring the list of substances of very high concern (Candidate List) and to send the proper SCIP notification if any of these substances is present in an item in concentrations above 0.1% (weight/weight) in compliance with the European Waste Directive table 2008/98/CE.
- It is committed to monitoring the list of substances that are mentioned in annex XVII with care to comply with the prescribed restrictions. The REACH restrictions list helps to protect human health and the environment from risks caused by chemical substances, by limiting the production, use and the input of certain substances on the EU market.
- It is committed to monitoring the list of substances mentioned in the regulations on Persistent Organic Pollution (POP) (Regulation EC n. 2019/1021 with care to comply with the prescribed restrictions.
